





#### Arms Control for the Third Nuclear Age Between Disarmament and Armageddon

David A. Cooper

The United States faces a new era of nuclear arms racing for which it is conceptually unprepared. Great power nuclear competition is seemingly returning with a vengeance as the post-Cold War international order morphs into something more uncertain, complicated, and dangerous. In this unstable third nuclear age, legacy non-proliferation and disarmament instruments designed for outmoded conditions are ill-equipped to tame the complex dynamics of a multipolar nuclear arms race centred on China, Russia, and the United States.

International relations scholar David A. Cooper proposes relearning, reviving, and adapting classic arms control theory and negotiating practices to steer the world away from threatening and destabilising nuclear arms races. He surveys the history of nuclear arms control efforts, revisits strategic theory's view of nuclear competition dynamics, and interviews US nuclear policy practitioners about both the past and the emerging era. To prepare for this third nuclear age, Cooper recommends adapting the Cold War's classical paradigm of adversarial arms control for the contemporary landscape. Rather than prioritising disarmament to eliminate nuclear weapons, this neoclassical approach would pursue pragmatic agreements to stabilise deterrence relationships among today's nuclear rivals. Diverging from other recent books on the topic, Arms Control for the Third Nuclear Age provides analysts with a more hard-nosed strategic approach.

Krieg and Rickli bring old, related practices such as war by mercenary or proxy under this new overarching concept.




#### **Finding Soldiers of Peace**

#### Three Dilemmas for UN Peacekeeping Missions Garv Uzonvi

The United Nations, which lacks its own peacekeeping force, faces three dilemmas when organising a peacekeeping mission: convincing member states to contribute troops, persuading states to deploy troops quickly, and securing a troop commitment long enough to achieve success. The key to overcoming these challenges, Gary Uzonyi argues, is emphasising the connection between peacekeeping and slowing the flow of refugees across borders. *Finding Soldiers of Peace* makes the case for this approach, which balances states' self-interests with the United Nations' goal of civilian protection.

Through an analysis of post-Cold War UN peacekeeping missions, particularly interventions in Mali and Sudan, Uzonyi shows how member states often tie civilian protection rhetoric to efforts to keep conflict-driven refugees from crossing into their territory. Conventional wisdom holds that member states primarily engage in peacekeeping for payment or humanitarian reasons. Uzonyi proves otherwise, helping scholars and practitioners more accurately predict which member states are most likely to send support, where states may send assistance, when they might become involved, the size of their contribution, and their timetable for leaving


## **Institution Building in Weak States**

**The Primacy of Local Politics** Andrew Radin

The effort to improve state institutions in post-conflict societies is a complicated business. Even when foreign intervention is carried out with the best of intentions and the greatest resources, it often fails. What can account for this failure? In Institution Building in Weak States, Andrew Radin argues that the international community's approach to building state institutions needs its own reform. This innovative book proposes a new strategy, rooted in a rigorous analysis of recent missions. In contrast to the common strategy of foreign interveners—imposing models drawn from Western countries-Radin shows how pursuing incremental change that accommodates local political interests is more likely to produce effective, accountable, and law-abiding institutions. Radin examines efforts to reform the central government, military, and police in post-conflict Bosnia and Herzegovina, Kosovo, Iraq, and Timor-Leste.





Japanese foreign intelligence is an outlier in many ways. Unlike many states, Japan does not possess a centralised foreign intelligence agency that dispatches agents abroad to engage in espionage. Japan is also notable for civilian control over key capabilities in human and signals intelligence. Japanese Foreign Intelligence and Grand Strategy probes the unique makeup of Japan's foreign intelligence institutions, practices, and capabilities across the economic, political, and military domains and shows how they have changed over time.

Brad Williams begins by exploring how Japan's experiences of the Second World War and its new role as a major US ally influenced its adoption of bilateralism, developmentalism, techno nationalism, and antimilitarism as key corents as a result, Japanese intelligence-gathering resources centred primarily around improving its position in the global economy throughout the Cold War. Williams then brings his analysis up to the Abe Era, examining how shifts in the international, regional, and domestic policy environments in the twentyfirst century have caused a gradual reassessment of national security strategy under former prime minister Shinzo Abe. As Japan re-evaluates its old norms in light of regional security challenges, the book concludes by detailing how the country is beginning to rethink the size, shape, and purpose of its intelligence community.

Anyone interested in Japanese intelligence, security, or international relations will welcome this important contribution to our understanding of the country's intelligence capabilities and strategy.






## Israel's Long War with Hezbollah



Diplomacy in pursuit of peace and security faces severe challenges not seen in decades. The re-emergence of strong states, discord in the UN Security Council, de-stabilising transnational non-state actors, closing space for civil society within states, and the weakening of the international liberal order all present new obstacles to diplomacy.

In *Diplomacy and the Future of World Order*, an international group of experts confronts these challenges to peace and conflict diplomacy. In doing so, they consider three potential scenarios for world order where key states decide to go it alone, return to a liberal order, or collaborate on a case-by-case basis to address common threats and problems. 
#### The US Military and the Challenge of Learning from Foreign Conflicts Brent L. Sterling

Preparing for the next war at an unknown date against an undetermined opponent is a difficult undertaking with extremely high stakes. Even the most detailed exercises and wargames do not truly simulate combat and the fog of war. Thus, outside of their own combat, militaries have studied foreign wars as a valuable source of battlefield information. The effectiveness of this learning process, however, has rarely been evaluated across different periods and contexts. Through a series of in-depth case studies of the US Army, Navy, and Air Force, Brent L. Sterling creates a better understanding of the dynamics of learning from "other people's wars," determining what types of knowledge can be gained from foreign wars, identifying common pitfalls, and proposing solutions to maximize the benefits for doctrine, organization, training, and equipment.

Other People's Wars explores major US efforts involving direct observation missions and post-conflict investigations at key junctures for the US armed forces. The case studies identify learning pitfalls but also

show that initiatives to learn from other nations' wars can yield significant benefits if the right conditions are met. Sterling puts forth a process that emphasises comprehensive qualitative learning to foster better military preparedness and adaptability.

#### America's Entangling Alliances 1778 to the Present Jason W. Davidson

Since the Revolutionary War, the United States has entered into dozens of alliances with international powers to protect its assets and advance its security interests. *America's Entangling Alliances* offers a corrective to long-held assumptions about US foreign policy and is relevant to current public and academic debates about the costs and benefits of America's allies.

Author Jason W. Davidson examines these alliances to shed light on their nature and what they reveal about the evolution of American power. He challenges the belief that the nation resists international alliances, showing that this has been true in practice only when using a narrow definition of alliance. While there have been more alliances since World War II than before it, US presidents and Congress have viewed it in the country's best interest to enter into a variety of security arrangements over virtually the entire course of the country's history. By documenting thirty-four alliances–categorised as defence pacts, military coalitions, or security partnerships–Davidson finds that the US demand for allies is best explained by looking at variance in its relative power and the threats it has faced.

Shocks and Rivalries in the Middle East and North Africa is the first book to examine issue-driven antagonisms within groups of Middle East and North Africa (MENA) states and their impact on relations within the region. The volume also considers how shock events, such as internal revolts and regional wars, can alter interstate tensions and the trajectory of conflict.

MENA has experienced more internal rivalries than any other region, making a detailed analysis vital to understanding the region's complex political, cultural, and economic history. The state groupings studied in this volume include Israel and Iran; Iran and Saudi Arabia; Iran and Turkey; Iran, Iraq, and Syria; Egypt and Saudi Arabia; and Algeria and Morocco. Essays are theoretically driven, breaking the MENA region down into a collection of systems that exemplify how state and non-state actors interact around certain issues. Through

Much recent scholarship about human rights has severed this link between the Holocaust, the Universal Declaration, and contemporary human rights activism in favour of seeing the 1970s as

the era of genesis. Morsink forcefully presents his case that the Universal Declaration was indeed a meaningful though underappreciated document for the human rights movement and that the Declaration and its significance cannot be divorced from the Holocaust.







This book provides much needed context and analysis to be able to understand recent Russian interventions in Crimea and eastern Ukraine, how to deter Russia on the eastern borders of NATO, and how the West must also learn to avoid inadvertent escalation.
