Over the last two decades, warfare has migrated into cities. From Mosul to Mumbai, Aleppo to Marawi, the major military battles of our time have taken place in densely populated urban areas. Why has this happened? What are the defining characteristics and the military and political implications of urban warfare today?

Leading sociologist Anthony King answers these critical guestions through close analysis of recent urban battles and their historical antecedents. Exploring the changing typography and evolving tactics of the urban battlescape, he shows that whilst some methods used in urban battle are not new, operations in cities have become highly distinctive. Today, urban warfare has coalesced into gruelling microsieges, which extend from street level - and below - to the airspace high above the city - as combatants fight for individual buildings, streets, and districts. At the same time, digitalized social media and information networks have communicated these battles to global audiences across the urban archipelago, with these spectators often becoming active participants in the fight.

A timely reminder of the costs and the horror of war and violence in cities, this book offers an invaluable interdisciplinary introduction to urban warfare in the new millennium for students of international security, urban studies, and military science.

In this new book, Mark Webber, James Sperling and Martin Smith explore four key post-Cold War developments that threaten NATO's survival: an overextended geostrategic reach and an unwieldly security policy portfolio; a failure to address capability short-falls and meet defense spending benchmarks; US weariness and European wariness that call NATO into question: and intra-alliance discord over Russia's place in the European security order and how to deal with Moscow's destabilisation of Georgia and Ukraine. The authors propose in response a range of policy options that could reinvigorate NATO, but conclude with a note of caution. Alliances come and go and most are cast into the dustbin of history. If NATO is to avoid this fate it must not only address the major problems that trouble it, but also get to grips with future challenges to alliance cohesion and credibility, from Brexit to the emerging contest with China.

There are few issues more contentious today than the nature and purpose of borders. Migration flows and the refugee crisis have propelled the issue of borders into the centre of political debate and revealed our moral unease more clearly than ever. Who are we to deny others access to our territory? Is not freedom of movement a basic human right, one that should be defended above all others?

Paul Scheffer takes a different view. Rather than thinking of borders as obstacles to freedom, he argues that borders make freedom possible. Globalization is accompanied by growing inequality which fuels alienation and resentment.
